Alcohol Result as confirmed by Gas Chromatography:

0.269 grams by weight of alcohol per one hundred milliliters (grams percent) of whole blood.

Cases with alcohol levels equal to or exceeding 0.170 g% in blood, 0.238 g% in urine, or 0.204 g% in serum or plasma will not be routinely screened for drugs of abuse. If the alcohol result meets or exceeds these levels and a drug screen is still needed, an e-mail requesting the additional analysis shall be sent to the crime laboratory at ADOISEvidence@dps.state.oh.us. Cases marked as fatalities shall be screened for drugs of abuse regardless of alcohol level.
